## **USE OF PROCEEDS OF THE RIGHTS ISSUE**

Unless otherwise defined, all capitalised terms used and not defined herein shall have the same meanings given to them in the Rights Issue Announcements and the Offer Information Statement lodged with the Monetary Authority of Singapore on 12 March 2018 (the "OIS").

The Board would like to provide an update on the use of the net proceeds of S\$18.8 million (the "**Net Proceeds**") from the Rights Issue. Following the Company's previous announcement dated 14 June 2018, the Company has utilised a further S\$0.9 million for business expansion purposes.

The details of the use of Net Proceeds to-date are tabulated below:

The above utilisation of the Net Proceeds is consistent with the use of proceeds disclosed in the OIS.

Subsequent to the aforementioned, the Company has a remaining balance of approximately S\$6.2 million from the Net Proceeds. The Board will continue to make periodic announcements on the utilisation of the balance of the Net Proceeds as and when such proceeds are materially deployed
